Directions to Start Point.....from I-270

From the South: Take I-270 NORTH to Exit 10, Rt. 117, Clopper Rd. At light turn RIGHT onto Rt. 117 WEST, Clopper Rd. Follow Clopper Rd. to Seneca Creek State Park entrance on LEFT. Enter park and turn RIGHT to Park Offices, our start point.

From the North: Take I-270 SOUTH to Exit 11, Rt. 124, Quince Orchard Rd. Turn RIGHT at light onto Rt. 124 SOUTH, Quince Orchard Rd. Follow Quince Orchard Rd. to Rt. 117, Clopper Rd. WEST. Turn right on Clopper Rd. and proceed to Seneca Creek State Park entrance on LEFT. Enter park and turn RIGHT to Park Offices, our start point.
