1. May 9, Seneca Creek State Park.
2. Jone Parr asked the question, "Are the Wednesday Walk driving directions used?". The answer was yes, so Jone said she will keep adding driving directions to each walk.

Old Business:

1. **May, June, July Edition of the Club Newsletter is online.**
 - a. Deadline for submissions to the next edition is July 15, 2018.
2. **Combining the Men's and Women's Dinners**
 - a. The combined Men's and Women's dinner will be May 29 at the Fontina Grill.
3. **Status of the Airports Special Program – Mike Cannon**
 - a. Mike Cannon passed around card stock that will be used for the log book.
 - b. He said that the Special Program proposal to AVA was mostly complete, but it does not have the required budget or an alternate Point of Contact.
 - c. Carolyn Thurber volunteered to be the alternate point of contact for this Special Program.
 - d. Mike Cannon formally proposed that the SVSVC submit the airport special program to AVA HQ for consideration as a 2020 Special Program. The proposal was seconded and passed without dissent.
 - e. If accepted by AVA, this Special Program will start in 2020, with log books available to be purchased until 2022.
4. **Status of Sanctioning the full Appalachian Trail in Maryland**
 - a. Alice Filemyr reported that Tom Jackson (former Atlantic Regional Director) suggested that SVSVC sanction the full AT this year.
 - b. Alice proposed that the SVSVC sanction this event as a seasonal, running July 1 - December 31.
 - c. Alice will send the sanctioning information to Maribeth Evans for input into the AVA ESR for sanctioning.
